DNA PROTOCOL WORKING PARTY 5/6/11

AIM

Verifiable DNA tests which create an audit trail

PREAMBLE

DNA tests are becoming more widely used. There is no obligation to place information in the public domain, but if there is any possibility that the information may be used for;

- 1. registration purposes,
- 2. to contribute to dispute resolution,
- 3. to demonstrate compliance with Legislation; then the following protocol as set out below must be followed.

The CCCA and its member bodies recommend that these protocols should be followed when conducting any DNA testing. Only the original Laboratory certificate will be accepted for the results to be included on the data base.

Collection Protocol Steps

- Contact a DNA Testing Laboratory and obtain a test kit and submission forms.
- Select a veterinary surgery to conduct the test. (a system is being developed of accrediting non-veterinary collectors).
- Ensure cat/ kitten is microchipped.
- Take the cat/kitten, testing kits and any other necessary paperwork to the collection point.
- The collector will scan the microchip, record the number on the paperwork- including registered name and number.
 The Collector will perform all tasks as requested on paperwork – including signing and dating.
- The DNA sample will be collected by the vet to ensure there is no contamination of the swab.
- The swap should be allowed to dry in a non contaminated area.
- Once dry, the swab is packaged by the collector, sealed and posted from the Collection point (not given back to the owner).
