Welcome to our first newsletter for 2021.


I wish you all a happy new year! I hope you have recovered from Christmas and are now settling in for the year ahead.

While it may be some time before we are returned to a fully "normal' year for shows, we are especially looking forward to holding our CFA shows this year subject, of course, to any continuing COVID-19 safe rules placed upon us by the NSW Government at the time of our shows. We will continue to ensure that our members, judges and workers are protected under our COVID-19 safe practices.

Something that I have witnessed and about which I *personally* am really concerned, is the number of Gumtree advertisements for kittens that are being advertised as available for rehoming at 8 weeks of age. I feel it is important to take this opportunity to remind our breeder members, that rehoming kittens <u>under 10 weeks of age</u> is contrary to our <u>Code of Ethics</u> and I would especially ask you to ensure that you are familiar with and abide by our Code. (NSW CFA Code of Ethics). These additional health safeguards are part of what distinguishes us from unregistered breeders. The other result of this early rehoming practice is that most of these kittens are being sold un-desexed, and usually with only <u>a single</u> vaccination. This early rehoming practice allows for the backyard breeder to pop up.

On a positive note, our Group 1 Judges course is recommending on 6 February, and it will be wonderful if we have no further outbreaks of Coronavirus to slow us down with this Course.

An article that you may find of interest this month is <u>Polycystic Kidney Disease (PKD in Cats.</u> Polycystic kidney disease is an inherited disease. Unfortunately, PKD has become very common in certain cat breeds.

- The litters (groups 1 3) do not have to be complete as long as there is more than one kitten in the photo; and
- The photos do not have to be current photos or current or even recent litters (pedigree section) or cats/kittens (Companions).
