## PERPETUAL TROPHIES and AWARDS

The purpose of competition at the Sydney Royal Easter Show is to encourage agricultural and pastoral excellence, ensuring the continual improvement of standards. In the 1870s the Society introduced regulations to govern judges and judging to ensure that competition was consistent and fair, and the tradition of Perpetual Trophies dates back to this time.

The Perpetual Trophies are the most prestigious of all RAS awards. They have a dual function in recognising superior effort in competition and commemorating people and organisations that have had a long and meritorious connection with the Society. Some of the trophies currently competed for were first won in 1911. Winners of Perpetual Trophies are permanently honoured, taking their place alongside past winners and becoming part of the ongoing tradition of the RAS.

The Perpetual Trophy Collection of the RAS is unique. It comprises a wide range of beautiful and elegant trophies that illustrate an extraordinary history of agricultural judging and the pursuit of excellence.

Perpetual Trophies remain the property of NSW Cat Fanciers' Association and the RAS of NSW. Ownership does not pass to the owner of the winning exhibit.




The below Perpetual Trophies will only be awarded on Sunday 13 April 2025. The winners name will be engraved on the Trophy and a medallion awarded in recognition of the achievement.

## EXHIBITOR Information AND ENTRY Requirements

- Judging:** Commences at 9:00am
- Vetting:** 7.00am to 8:30am – No late vetting will be conducted
- Pavilion:** The 2025 ADVANCE™ Sydney Royal Cat Show will be held in Hall 3 - Pet Pavilion. The Pavilion will be open to the public from 9am to 5pm.

### **Parking:**

Parking is NOT included or paid for via your show entry.

We recommend pre-booking parking as early as possible to ensure you secure a spot.

### **Exhibition of Cats:**

All Exhibitors must supply a base of towelling or cotton measuring 560mm x 510mm. Plain coloured bases are permitted. Items such as lace, ribbon, cord must not be left in cages. Any items that could become entangled will be removed by the Chief Steward.

All Exhibits must remain in the Pavilion until 5pm. Only the Owner, or their representative, may remove the Exhibit at the end of the day.

### **Amendment to Judging Timetable:**

NSW Cat Fanciers' Association Inc reserve the right to change the Judging Timetable if necessary.

**Group 4:** Cats registered as Companion Cats

## CONDITIONS OF ENTRY

Exhibitors must adhere to the Conditions of Entry to Sydney Showground located at [www.rasnsw.com.au](http://www.rasnsw.com.au), the RAS General Regulations and the Special Sydney Royal Cat Show Regulations in this Schedule (the "Regulations"). A condition of entering Competitions is strict adherence to the Regulations. Accordingly, Applications for Entry in the name of deceased Person(s) are not eligible for entry. The Application for Entry and the Regulations constitute the whole agreement upon which Entries are submitted and the Exhibitor agrees that all representations and statements not appearing on the Application for Entry or in the Regulations are excluded.

The Exhibitor certifies that each animal Exhibited by them or by their child/children/guardian is duly registered and either their property absolutely or is under their absolute care and control. The Exhibitor holds the NSW Cat Fanciers' Association Inc (NSWCFA) exempt from any liability in the event of any loss or damage from any cause whatsoever.

A refund of Entry Fees shall not be made unless a notification of withdrawal is received by NSWCFA in writing before the closing Day of Entry. A refund will not be issued until all unused passes have been returned to NSWCFA.

The RAS has the power to evict any Exhibitor from the Showground.

## Requirements & Regulations

1. Fees must be paid with Entry. Fees are not refunded for Exhibits not shown.
2. All Exhibits must be under the Owner's name. Cattery prefixes will not be accepted as Owners.
3. A copy of the registered pedigree must accompany the Application for Entry for each pedigree Exhibit entered. This includes online entries.
4. Exhibits will be judged under the breed standards of the Co-Ordinating Cat Council of Australia (CCCA). It is not however a requirement for Exhibitors to be a member of the Co-Ordinating Cat Council of Australia.
5. COLOURS; Agouti is defined as Tabby.
6. Any protests must be in writing and lodged with the NSWCFA, together with \$25 fee, within seven (7) days of the Show. Fee returnable if protest upheld.
7. A cat/kitten must be entered in all rings of the Show in the OPEN CLASS for adult cats and an AGE CLASS for kittens subject to the Schedule as classified.
8. A cat/kitten or any other animal, other than an Exhibit, shall not be allowed in or within the precincts of a Show during the conduct of the Show, except on Exhibition.
9. All cats Exhibited at the Show must be fed by the Exhibitor and no foodstuffs are allowed in the cages prior to Judging.
10. Cats must be at Hall 3 - Pet Pavilion from 6.30am on Sunday, 13 April 2025. Cats must remain on exhibition until 5:00pm.

## VETTING

11. No cat will be admitted to the Pavilion after 8:30am for examination by the Official Veterinarian of the RAS.

12. The vetting examination will take place in the Veterinarian's room in the Pavilion. Cats will not be examined inside the Pavilion. If approved, the cat must be benched at once. No person, except the Owner or their representative will be allowed in the Pavilion until after the cats have been examined and benched.

13. All Exhibits must be vaccinated. Vaccination must have been carried out no less than 14 days prior to the date of the Show. Exhibitors must have the current vaccination record available for each Exhibit at vetting.

14. Any Exhibit which shows symptoms of any disease, is flea infested and/or dirty must be removed from the Showground at once.

15. All Companion cats over the age of 6 months must be desexed.

16. Challenges will be awarded to Best Entire Male, Female, Neuter and Spay in each colour section.

17. No Exhibit shall be removed from the Pavilion between the hours of 9am and 5pm, unless a veterinary certificate be produced stating that the cat is not fit to remain on the bench or is given special permission from the Chief Steward.

18. No cat or kitten shall be removed from its cage during the Show for any purpose whatsoever without the authority of the Chief Steward. If a cat is to be removed from the cage it must have a harness or leash attached at all times (except during judging).

19. NSWCFA will not, under any circumstances, hold itself responsible for any loss or misdelivery of livestock or other Exhibits at the ADVANCE™ Sydney Royal Cat Show or any damage thereto.

20. Any Exhibit which is unable to be handled or which is found to be under sedation will be disqualified. An Exhibit which cannot be handled by an Official of the RAS or NSWCFA at any time at the Show shall be deemed to be fractious and shall be reported.

21. The age of all Exhibits will be the actual age on the first day of Cat judging at each Show. A kitten is defined as being 12 weeks and under 9 months of age on the first day of Judging.

22. No entries will be accepted for kittens under the age of 10 weeks.

23. Kittens shall not be eligible to compete in Classes other than for kittens.

24. Desexed Exhibits shall not compete against entire Exhibits except where Special Regulations apply as in side Classes such as eye colour, etc. or for Supreme Exhibit. For Top 5 Kittens, male and female kittens will be compete separately however desexed kittens will compete together.

## JUDGING

25. Judging of Exhibits will be Australian Open Championship style where the Judges officiate in front of Exhibitors and the general public and speak with the audience about the cats being judged.

26. CCCA Awards (where merited) will be awarded at the Open Championship Show only in all rings to the best

placed Exhibit Male, Female, Neuter, Spay in Groups 1, 2, and 3.

27. NSWCFCA may, in any circumstances which it thinks fit refuse to accept the Entry of an Exhibit, or may at any time cancel any Entry already accepted and may disqualify the relative Exhibit from competing or Exhibiting in any specific Class or Classes or Events and without prejudice to the generality of the foregoing the RAS shall so act if a report of the Veterinarian upon the relative Exhibit discloses that the Veterinarian considers or finds that the Exhibit:

(a) is affected with any contagious or infectious disease, or is obviously in kitten, or is known to have or is suspected of having been brought onto the Showground from a cattery in which an animal is affected by or suffering from a contagious or infectious disease or which an animal was affected by or suffering from a contagious or infectious disease within 30 days or the relevant incubation period whichever is the shorter, prior to the date upon which the relevant Exhibit was brought onto the Showground.

(b) shows any signs of any surgical or other artificial interference which is calculated to deceive or is capable of deceiving either Judge or spectators.

28. All Exhibits must be brought into the Pavilion securely contained in an adequate carrying receptacle.

29. Exhibit Unworthy of Award. The Judge may in his/her absolute discretion and without assigning any reason therefore, decline to make an Award in respect of any Exhibit.

30. If any Exhibit is not in its cage when the Judges are called to the floor, the Exhibit will be automatically disqualified.

31. All Exhibits (local, interstate or overseas) must comply with the Full Register rules and Regulations as applicable in NSW. Any breach will render Exhibits liable to disqualification.

#### PENALTY: NON-EXHIBITION OF CATS

32. An Exhibitor making an entry may be subject to a fine of \$50 for each entry not Exhibited, unless notification under the hand of the Exhibitor or his authorised agent be lodged with the NSWCFCA prior to the commencement of Judging the Class in which the Exhibit is entered to the effect that such non-Exhibition is caused either by:

- (a) the death of the animal or animals,
- (b) contagious or infectious disease confirmed by a veterinary certificate, or
- (c) any other reasonable cause acceptable to NSWCFCA.

33. All Exhibits must be registered with a recognised Governing Body.

34. Use of methylated spirits or atomiser sprays in the hall are not allowed.

35. An Exhibitor or handler of an Exhibit shall not use talcum powder or other like substance on an Exhibit whilst an Exhibit is caged or whilst in the vicinity of the cages.

36. No cat obviously in kitten is allowed to be entered.

37. All experimental Exhibits entered must be from an experimental program from a recognised Governing Body. The type of cat for which the breeder is experimenting in

such program and the generation must be stated on the Application for Entry.

38. Breeds and colours/patterns that are not recognised by the CCCA are not eligible for entry.

39. All breeds accepted by either ACF or CCCA are eligible to enter the Open Championship Cat Show on Saturday 8 April 2023.

#### EXHIBITOR CONFIRMATION ADVICE & DASHBOARD SLIPS

40. The Exhibit Confirmation Advice, otherwise known as a bench slip, indicates the Class in which your cat/s have been entered, and is required for access to the Showground. A Dashboard Slip will also be issued to Exhibitors with the Showtime Authorised Contact Person's mobile number printed on the slip. A Dashboard Slip must be displayed on the dashboard of each vehicle at all times while on the Showground.

#### EXHIBITOR PASSES

41.

- 1 - 3 cats: Two (2) one-day entry pass
- 4+ cats: Three (3) one-day entry passes

#### PROHIBITED SUBSTANCES

42. Refer to the General Regulations.

#### ACKNOWLEDGEMENT, RELEASE AND INDEMNITY

43. Refer to the General Regulations.

#### OFFICIALS EXHIBITING AND JUDGING AT THE SAME SHOW

39. Stewards will be allowed to Exhibit and officiate at the same Show however:

- (a) Stewards must not discuss entries with Judges, nor must they offer their opinion or pass comment on any Exhibit during the judging process.
- (b) Stewards must not discuss results with, or otherwise relay results to, other Stewards, Judges or Exhibitors.
- (c) Judges will **not** be permitted to Exhibit and judge at the same Show.
- (d) It is the responsibility of the Chief Steward to ensure that all Stewards abide by the RAS guidelines.

#### SUPPORTER PRIZES

Prizes are provided by third parties and may not be awarded for all places. NSWCFCA advises that any such prize may be subject to change or amendment occurring at any time, thereby making the original information published incorrect.

#### PERPETUAL TROPHIES

# Judges



## John Smithson (NZ Cat Fancy) – Ring 1

In his professional life, John has been a Credit Manager for more than 35 years and is currently Key Account Credit Manager for Porter Group, which is the largest heavy equipment hire company in the Southern Hemisphere. His involvement in the Cat Fancy began in the late 70's, registering his first prefix 'Imperatus' with the NZCF in 1978, and shortly afterward was appointed Editor of 'NZ Cats' Magazine, when in 1980, he produced the first NZCF Yearbook. In the intervening years, John began by breeding Persians and Himalayans, extending to British Shorthairs, Burmese, Siamese, and Exotic Shorthairs. He bred NZ's first Red Persian Grand Champion and first Himalayan Double Grand Champion. Later he graded a British

Shorthair in CFA (USA), and bred Orientals, Foreign Whites and latterly Munchkins, culminating with 9 Grand Champions and taking one to All-Breed Cat of the Year in 2009.

In 1985, he passed his Long-hair Judges exams and began his judging career, later extending to cover all Short-hair breeds in 1990. He has held various positions such as Club Delegate, Secretary and/or President, of several NZ clubs, serving for a time as Northern Region Chairman and on the National Executive, and was ultimately elected as National President of the New Zealand Cat Fancy in 1992, serving on the CFA International Committee in 1993. John is currently listed as an All-Breed Tutor Judge with the NZCF.

In 2009 John founded 'The Harrison Weir Collection,' and over the last decade has accumulated the world's largest private collection of original antiquarian art, ephemera, and publications featuring the work of British listed artist, Harrison William Weir. John also manages and edits the educational web-site [www.harrisonweir.com](http://www.harrisonweir.com). This collection was later expanded to separately include historical items relating to the history of cat shows, honouring Harrison Weir's role as the 'Father of the Cat Fancy'.

In 2014, 'The Harrison Weir Collection' entered into a collaboration with 'The CFA Foundation,' which runs the Feline Historical Museum, based in Alliance, Ohio. This new collaboration included joint development of a new web-site at [www.cat-o-pedia.org](http://www.cat-o-pedia.org) now well known as 'The History Project,' with Karen Lawrence, who is the Director of the Feline Historical Museum. John spends a great deal of his time writing many of the individual cat histories of the late 19th and early 20th century cats which may be found on this site.

When the World Cat Congress was held in New Zealand, John was invited to be one of the five guest speakers, delivering a presentation on Feline History. In April 2017 he spent a month in the UK on a research tour, collecting material for a new in-depth biography of Harrison Weir, while concurrently giving presentations to history groups, on the art, life and passions of the Father of the Cat Fancy.

John was recently invited to serve on the CFA Foundation's Board of Directors, with whom he is now working to further the aims and future direction of the CFA Foundation and the Feline Historical Museum. In 2018 he spent a week in the Museum doing historical research after giving a series of four history presentations in the Education Ring at the CFA International Show.

With the arrival of Covid restrictions in 2020, he launched the new e-magazine 'Felis Historica' as a platform for disseminating both feline-related history and current affairs on an International scale. The magazine provides over 100 pages monthly of topical information on breeds, genetics, and other feline related issues relative to both Domestic and Pedigreed cats.



## Sue Ford (NZ Cat Fancy) – Ring 2



I was raised on a beef and sheep farm in the Manawatu in central North Island. As a child I had a menagerie of animals - cats, horses lambs, hens, ducks, calves and injured birds to care for and still have a similar menagerie.

My major degree was at Canterbury University and I went on to teach English. I retired from teaching after reaching Principal status. Education has been a passion and I continued to do management and administrative diplomas which lead to several overseas trips as a New Zealand representative.

I still am involved on a casual basis and support my maths teaching husband Rob. We live on a lifestyle block near Hamilton and other than raising Burmese kittens we enjoy the outdoors, gardening, music, theatre and food with great wine. Our adult sons and our grandchildren live in Tennessee and Invercargill which means we don't have much contact, but thank goodness for social media.

Judging: I have been involved with the Cat Fancy since buying my first real pedigree Burmese cat in 1980s. Domestic moggies, Burmillas and Siamese have also lived with us. I started judging Short hair cats in 2004 and completed Long hair training in 2010. To date my judging has been with both NZCF and Catz Inc in New Zealand and in

Australian for CCFA, ANCATS, CCCofA, FCCWA, GCCF in Ireland and I have observed cat shows in the UK and the USA on two occasions.

Role in NZCF: Appointed to NZCF Judges Council, a Tutor Judge, delegate and Show Secretary for Mid Island Cat Club where I am a Life Member.

I love meeting people and cats and always feel privileged to judge beautiful, healthy cats whose owners love and care for them as they would their own family.

## Phillipa Perkins (NSW CFA) – Ring 3



I have been involved with the cat fancy since 1987 – 35+ years !! From when I first registered my breeding prefix “SINJIN” in 1998, under which I have exclusively bred Siamese and Orientals and much to my delight achieved numerous Breeder/Owner – Cat & Kitten of the Year awards over the years.

I'm a founding and life member of “The Oriental Cat Club of NSW” (Est 1989) and have over the years of my involvement with this club held the positions of – President, Vice President , Treasurer and Show Manager/Show Secretary.

In July 2022, I was proudly presented with a “Honorary Membership” from the New Zealand Siamese Cat Association which I had the privilege of judging for in Christchurch NZ.

I became an approved steward in 1994, and then a NSW CFA Companion judge in 1999. In March 2017, I successfully completed with NSW CFA the All Shorthair Judges training course (Groups 2 and 3) and was granted my All Shorthair Open Judges Licence. In August 2022, I advance to being an All Shorthair Tutor Judge.
